Meeting was called to order at 6:25PM

- Pat Frey spoke with members about her running for District 7 School Board (this is Waverly Terrace's District). Christina Barnes introduced her and several questions were asked about her stance on:
 - a. CRT "CRT is not taught in Muscogee County school curriculum and not part of her agenda." "All students have a right to a good education."
 - b. Parental involvement "Recommends a parent advisory committee to have a direct impact of curriculum. Would like to see PTA return."
 - c. She has lived in District 7 since 1978.
 - d. Plan for Covid catch up In place now is the "Summer Learning Experience" offered to students struggling from missing classes in the past.
 - e. Do you support the Biden administration? She is Independent, fiscally conservative, and more liberal on social issues
 - f. Her ideal is to prepare students and families holistically... fix issues at home will result in better future careers for students. She also wants to give students a chance to live their dreams and excel out of poverty

Early voting has begun at the Citizens Service Center (Macon Road) Regular election is June 20th at Epworth UMC (Our regular precinct)

2. Sidewalk Ramps in Waverly Terrace
